COMPLIANCE:

Beech Aircraft Corporation considers this to be a mandatory inspection and it should be accomplished within 25 service hours after receipt of these Service Instructions or at the next annual inspection, whichever occurs first. FAA AD 76-16-02, Amendment 39-2685 or subsequent, has been issued on this subject.

**DESCRIPTION:** 

All Airborne P/N 113A, 200CC and 200CW dry air pumps as specified under EFFECTIVITY are to be inspected for serial numbers which indicate manufacture prior to 1966. Any of these pumps which are found with serial numbers prior to 1966 (listed in ACCOMPLISH-MENT INSTRUCTIONS) are to be replaced with new pumps.
